# **CALL FOR APPLICATIONS 2019/20 INTAKE**

The University of Dar es Salaam, invites applications for admission into the Master of International Trade (MIT) programme.

# **Objective of the MIT Programme:**

The Master of International Trade (MIT) program gives students a balanced blend of macro and micro courses that are necessary to enable them to appreciate the linkages between macro policy issues relating to trade management and micro strategic issues relating to business management in view of increased international business interactions. In this regard, the MIT is a postgraduate degree programme designed to create world-class trade policy and business managers, who can serve the real needs of governments, businesses and other institutions that have trade and international business agenda.

#### **Commencement:**

The program is scheduled to commence in March, 2019.

## **Duration:**

The Program runs for 18 months and is offered on a modular basis consisting of four taught modules. Candidates will also be required to undertake internship in an organization dealing with international business and will be required to do research leading to a dissertation.

## **Minimum Entry Requirements.**

- i. Applicants must be holders of a Bachelor's degree with a GPA of at least 2.7 of the University of Dar es Salaam or its equivalent from any other accredited University in areas of Business, Economics, or related fields. OR
- ii. Candidates with a pass degree in the relevant areas may be considered if they have at least 5 years working experience after graduation, and they have evidence of post graduate training lasting at least 6 months or

- iii. Holders of an Upper Second Advanced Diploma from an accredited higher learning institution plus a Postgraduate Diploma. OR
- iv. Have a recognized professional qualification such as ACCA, CA, CPA, CPSP, CIB, MCIM, CIMA and at least two years experience in a job related to international business.
