## THE 51stGRADUATION AGREEMENT FOR HIRING OF ACADEMIC COSTUMES

| 1.       | The Borrower shall pay the owner a hire charge of <b>TZS 45,000/=</b> for the said costumes and convocation fee.  |
| 2.       | The Borrower shall during the period of hire and at his/her own expense keep the said costumes in good condition and shall be responsible for all risks of loss or damage to the said costumes.   |
| 3.       | The Borrower shall return the said costume to the Owner immediately after the graduation ceremony and in any case <b>NOT LATER THAN SEVEN WORKING DAYS</b> after the date of the graduation ceremony.   |
| 4.       | A penalty of <b>TZS 10,000/=</b> shall be charged for each day of default to return the hired costumes and in the event of loss of the costume the owner shall be entitled to recover such loss at the current replacement cost of a new costume from the Borrower.                               |
| 5.       | A defaulting Borrower <b>SHALL NOT BE ISSUED</b> with either a degree <b>certificate</b> or <b>academic transcript</b> unless and until either the costume is returned or full replacement cost of a new costume is paid and only after discharging the full penalty due under paragraph 5 above. |

After paying, you should submit the pay-in slip to your respective College/ School or Institute for receipts. The time table for collection of Graduation Gowns will be posted in the University website and notice boards.
